On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

We were required to return the Annual Return to enable the Council to correct an error relating to fixed assets at Box 9 in Section 2. The Council used a revaluation to complete Box 9. Proper practice requires fixed assets to be disclosed at initial cost, or a proxy such as insurance value when the initial cost is not known, and this value does not change until the asset is disposed of.

Fixed assets were also overstated because community assets (including the war memorial and pond) had not been valued at £1 as required by proper practice.

In future the Council should ensure that it records fixed assets in the Annual Return following proper practice.
